- Contacted a consulting company for assistance with the FEMA reimbursement process.
- Next Monday we have our kickoff meeting with performance review auditors.
- Busy with closing of the fiscal year and beginning of the new fiscal year.
- The next meeting will be held on November 28, 2022 on the fourth Monday of the month, the week after Thanksgiving.

By Chief Manson –

- Spent a lot of time on the hurricane.
- Starting the new year purchases and getting back to normal.

Commissioner Hoke asked if we get reimbursed for overtime? Yes, we will get reimbursed.

Commissioner Ballard asked if we would pay for the roof? We will be working with insurance and FEMA to reimburse the roof.
